Suzanne Lane and Phil Wages. both of KEPCo, attended the Kansas Transmission Policy Summit in Lawrence, Kansas, hosted by Kansas House of Representatives member Tom Sloan. The keynote speaker was Mr. Neil Chaetterjee -FERC Commissioner. Other included Ms speakers Catherine Jereza - Department of Energy Deputy Assistant Secretary, Ms. Shari Feist-

Albrecht - Kansas Corporation Commission Commissioner, Mr. Paul Suskie - Southwest Power Pool, and speakers from organizations that included MISO, Manitoba Hydro, NREL, ITC Great Plains, Tri-State, and the American Wind Energy Association, among others. A wide range of topics were discussed such as FERC Order 1000, national security of the transmission system, grid-scale storage, inter-regional seams issues, east-west grid interconnections, distributed energy resources, transactive energy systems, streamlining federal and state transmission siting processes, among several others.

## **KEPCo Submits REDLG Loan Applications**

KEPCo, and its member cooperatives, have a long, successful history of utilizing the USDA Rural Economic Development Loan and Grant (REDLG) program for economic development opportunities in rural Kansas communities. This summer, KEPCo worked with several applicants across the state and submitted REDLG applications to USDA on their behalf. If each application is approved, over \$2.5 million in capital will be brought into rural Kansas and nearly 100 jobs will be created or saved.



# **KEPCo Attends SPP Legislative Conference**

Suzanne Lane and Phil Wages, both of KEPCo, attended the fourth annual Southwest Power Pool (SPP) Legislative Conference in Washington, D.C. Presenters at the conference included U.S. Congressmen Steve Womack and Fred Upton, Mary Martin (Chief Counsel, Energy and Environment, House Energy and Commerce Committee), Kellie Donnelly (Chief Counsel, Senate Energy and Natural Resources Committee), lobbyists for NRECA, APPA, AWEA, and EEI, James Danly (Chief Counsel, FERC), and former U.S. Congressmen Martin Frost and Cliff Stearns.

Following the conference, Kansas electric utility lobbyists called upon each of the Kansas Congressional Delegation to discuss current utility issues.

# **KEPCo Secures Power Supply Agreement**

For over six months, KEPCo staff worked diligently to secure power supply for a portion of KEPCo's load. The load has a peak of approximately 14 MW and had been previously served under a supply agreement with Sunflower. With the expiration of this agreement set for December 31, 2018, retaining a new, cost-effective, reliable power supply in a timely fashion has been crucial.

In early 2018, it was determined that considering the many changes in the SPP Market and capacity availability since the last time KEPCo secured a power supply, the most efficient, effective method for securing power supply for this load was to initiate a Request for Proposals (RFP) process. With the guidance and support of the KEPCo Board of Trustees, KEPCo staff contracted with the Alliance for Cooperative Energy Service (ACES) to facilitate the RFP process. ACES is based in Carmel, Indiana, and not only provides energy services for its 21 member-cooperatives from across the country, but they also provide services to non-member clients, such as municipal utilities, investor-owned utilities (IOUs), independent power producers, and cooperatives like KEPCo. KEPCo staff and ACES were pleased with the responses received via the RFP process. KEPCo received 25 responses from 15 separate entities, and the responses included a variety of energy products, services, and contract terms. With close interaction with ACES and the continued empowerment and support from the KEPCo Board, KEPCo was able to short-list the responses based on cost, contract term, product structure, and deliverability.

After much analysis and consideration of all aspects, KEPCo staff concluded that entering into a two -year agreement for capacity with Sunflower was the best option. This agreement provides mutual benefit to both KEPCo and Sunflower, and KEPCo is very appreciative of the partnership and interest from Sunflower in serving this load. The associated agreements have been filed with both the Kansas Corporation Commission (KCC) and the Rural Utilities Service (RUS) for approval.

In addition, KEPCo entered into an agreement for energy management services with Sunflower. As for the energy component, KEPCo is continuing to work with ACES on opportunities to minimize financial risk in the SPP Market, while still assuring KEPCo provides the most cost-effective, reliable service to its membership.
