2018 Legislative Session Update



This year, there was an inordinate amount of bills introduced. The bills covered many topics, which included efficiency and demand energy management, retail electric rate relief, numerous broadband bills. service metering, and territory termination protection, among many others. Below is a brief description and disposition of a few of the bills that will or could have impacted KEPCo and its members.

Kansas State Capitol

- KEPCo provided opposition testimony on SB374, which would have re-wrote the Kansas Energy
 Efficiency Act and permitted utilities to have an unbridled spend on demand-side management
 and energy efficiency programs that did not need to be proven cost effective. The bill was not
 worked.
- SB322 would have rolled-back the net metering thresholds to the original 2009 levels. This bill
 was brought in response to the KCC Docket that allows Westar Energy to present in future rate
 cases a higher customer charge for distributed generation customers. The bill was heard but not
 worked.
- KEPCo provided proponent testimony on SB385 and HB2640 (same bills) which would mandate
 that the KCC provide a public comment forum at least four times per year for transmissionrelated decisions at the SPP. KEPCo's testimony pointed out that KEPCo's transmissions costs
 have increased 87% since 2010. The bill was not worked.
- KEPCo provided joint testimony on HB2513, a bill that would have increased the surface water protection fee. This would have impacted costs at Wolf Creek. The bill was not worked.
- SB323 (service territory termination process) was combined with two other bills and was passed favorably out of the House and Senate Utilities committees. The electric cooperatives and municipals compromised on language in the bill, which now requires a notice, requires record keeping, and the annexing of undeveloped land will be compensated at 8.5% of gross revenues for 10 years, once the property is developed.
- SB396 would have prohibited electric utilities from including amounts in excess of applicable tax rates in electric rates. The bill received a hearing, supported by the Kansas Industrial Consumers Group and Americans For Prosperity, but was not worked.
- HB2701 establishes a 23-member statewide broadband expansion task force to work collaboratively to evaluate the broadband needs of Kansas citizens, businesses, industries, institutions and organizations. The bill passed favorably out of both the House and Senate utility committees.
