#### A Moment with the CEO

With the changing in the seasons from summer to fall comes picturesque foliage, exciting football games, cooler temperatures, and a back-to-school Here at KEPCo, fall also routine. strategic means planning implementation, the end of the peak season, another refueling outage at the Wolf Creek Generating Station (WCGS), a renewed commitment to safety, and the completion of a muchanticipated, demand-side management (DSM) study.

With regard to strategic planning, our Board of Trustees and senior staff recently completed KEPCo's first strategic planning session since 2016. This was a great opportunity to evaluate our areas of strength and opportunities for improvement, and was ideal timing considering half of our Board members are new since 2016, as are the members of our Executive Team. Brad Kitchens, with ScottMadden, Inc., led us through the effort, which resulted in five key areas of focus: risk management, economic development, management, rates and rate design, and emerging technologies. We are now formulating measurable, reportable goals to assure these areas - in addition to our core purpose of providing reliable, reasonably-priced power - are at the forefront of our mind as we continue partnering closely with our members on these important initiatives.

The 2019 peak season was the reversal of the adage "in like a lion, out like a lamb." Despite record-breaking precipitation, the summer started out mild. We eventually saw some of the Kansas heat and humidity to which we are accustomed, but when looking at the entire summer in aggregate, we saw lower overall energy sales, a lower average peak demand, and less need for peak management from our membership. We can't express enough appreciation for our members' - and their members' - support and efforts this summer to help us operate efficiently and in a manner that finds the most cost savings for our members.

Another significant event for KEPCo that takes place

this fall is the 23<sup>rd</sup> refueling outage for WCGS. This important endeavor occurs approximately every 18 months at nuclear reactors like WCGS, and is very crucial from a safety, cost, and production perspective. The staff at WCGS has a detailed schedule that involves heavy planning, coordination, and communication, all while assuring safety remains the #1 focus. The outage is planned for 40-45 days, and in the interim, the replacement energy for our members comes from our power supply agreement with Westar Energy.

Like many of our members' managers, I had the privilege of recently completing the National Rural Cooperative Association's "Commitment to Zero Contacts" to demonstrate my commitment to our employees' and members' safety. In addition, our Board of Trustees passed a resolution formalizing their commitment to and support of our staff's safety as well. These public examples of our dedication to safety, in addition to the recent formation of KEPCo's first Safety Committee, place constant emphasis on the expectation to act safely, and a renewed excitement for creative training, sharing, and practice enhancements are just a few of many reasons that our team continues to work with zero safety incidents in over six years!

As for DSM, we are very close to finalizing – in close partnership with our members and a consultant -KEPCo's first DSM study. The scope of this study involves fully evaluating all aspects of KEPCo's current rate structure, practices, power supply contracts, services, programs, and members' desires, while incorporating ideas for enhancements to the current framework. The ultimate goal is to partner with our members to determine the ideal DSM program(s) from a cost-minimizing, operational effectiveness, memberfriendly perspective. We look forward to the outcome of the study, and to working side-by-side with our members implement any resulting recommendations as efficiently as possible.

These are just a few of the many exciting activities we have going on here at KEPCo. We wish everyone a safe, enjoyable autumn and holiday season, filled with happiness, blessings, and precious time with family! And happy "Cooperative Month" in October!

# LCC Selects Consultant for Rate Study

On July 29, the Legislative Coordinating Council selected, by unanimous vote, London Economics International, LLC (Boston, MA.) as the consulting firm to complete the first section of study topics in Substitute for Senate Bill 69 (retail rate study bill). Topics to be studied include retail choice, various aspects of rate making, net metering, transmission investment, securitization, and taxes, among others. Section one is to be completed and published on the Kansas Corporation Commission website by January 8, 2020. Section two of the bill has been let for Request for Proposal, with responses due later this year.

# KEPCo Selected to Receive NRECA Cybersecurity Training



KEPCo has been selected as a Category B participant to receive cybersecurity training through NRECA's Rural Cooperative Cybersecurity Capabilities (RC3) program. The program is made available to electric cooperatives, at no cost, through funding from the U.S. Department of Energy.

The RC3 program is dedicated to promoting a culture of cybersecurity and improving the cybersecurity and resiliency capabilities of the electric cooperative community. The program approaches building cybersecurity awareness and resiliency using a portfolio of resources, training, and technical assistance specifically shaped to support the cooperative community.

The training for Category B participants is geared towards staff of distribution/G&T cooperatives who have cybersecurity experience and who are willing to mentor staff from other cooperatives to help them improve their cybersecurity skills.

#### **Matt Ottman Receives Certifications**



This summer, Matt Ottman, Information System Specialist II, received two certifications from CompTIA. Both certifications required weeks of studying and passing written exams.

One of the certifications from CompTIA is Network+. This certification encompasses the design and implementation of functional networks; configuring, managing, and maintaining essential network devices; the use of devices, such as switches and routers, to segment network traffic and create resilient networks; identifying benefits and drawbacks of existing network configurations; implementing network security, standards, and protocols; troubleshooting network problems; and supporting the creation of virtualized networks.
