## **Cunningham Attends NRECA Legislative Conference**

A contingent of twenty-three Kansas electric cooperative representatives attended the NRECA Legislative Conference in Washington, D.C., April 28-30. Susan Cunningham, Senior Vice President, Regulatory and Government Affairs, and General Counsel, represented KEPCo.

Nearly 2,000 electric cooperative representatives were present in Washington to convey industry issues to their respective congressional leaders. Each year the conference is the largest electric cooperative grass roots event in the nation's capitol.

Issues discussed with House and Senate members included ways electric cooperatives can participate in infrastructure development; concern over the proposal to sell power marketing association assets; the need to reform the Pension Benefit Guaranty Corporation premium calculations; and a return to the previous tax provisions of removing grant funds from non-member income calculations.

## 2019 Legislative Roundup

The 2019 legislative session was extremely busy, as numerous bills were debated in both the House and Senate utility committees. When the dust settled for the year, Senate Substitute for Senate Bill 69 advanced through both chambers. The bill is a compromise among utility companies and entities that, beginning early in the session, were seeking a study of electric rates and issues affecting utility rates. The bill contains 29 various "study" items to be addressed by an outside consultant(s) selected by the Legislative Coordinating Council via a Request For Proposal. The bill is divided into two sections, with the first

section to be completed and published on the KCC website by January 8, 2020, and the second section to be completed and published on the KCC website by July 1, 2020. The first section of study topics includes ratemaking principles and optional ratemaking methods, investments in utility infrastructure, retail choice, energy efficiency, and securitized ratepayer-backed bonds, among others. The second section of study topics includes an examination of electric vehicle charging stations' cost recovery, transmission investment, and commercial and industrial rates, among others.

HB 2178, which amended the Kansas Underground Utility Damage Prevention Act, was also passed this year. The bill amends the definition of "operator" to specify an electric public utility is not considered an operator with respect to privately-owned underground lines, and therefore, the utility is not required to locate and mark such privately-owned lines.

### Lane Attends MIT Nuclear Reactor Course

In June, Suzanne Lane, KEPCo EVP & CEO, will attend the Reactor Technology Course for Utility Executives at the Massachusetts Institute of Technology in Cambridge, MA. The course is an intensive, three weeks of study designed to provide a fundamental understanding of the principles of nuclear technology as they relate to the management and operation of commercial nuclear electric generating units. The course also enables utility executives to recognize the limits of their knowledge of reactor technology and how these limits should be respected when making related management decisions, as well as provide utility executives with a greater sense of importance of personal involvement, ownership, and respect for the reactor core and nuclear safety.
